Further all the above mentioned colleges who have been granted fresh provisional affiliation for the session 2012-13 shall ensure that the following general conditions are also fulfilled:-

1. Selection of Principal and staff be made through duly constituted committee up to 31th March, 2013 positively failing which their request for extension of provisional affiliation shall not be considered by the University for the session 2013-14.
2. Creation of email ID mandatory. Hence all the communication through email ID and shall be deemed to be proper mode of service on the institution.
3. Principal and one other staff should be a member of the managing body.
4. Payment of salary be made through cheque and as per norms.
5. Laboratories be properly equipped.
6. Books and Journals in the library be maintained as per norms.
7. Clear land title in the name of institution or the society/trust which running the institution.
8. Building plan be approved by competent authority.
9. In case of Co-Education, separate provision for girl's toilets should be made.

All the Colleges will follow the rules and regulations/directions/guidelines of the State Government/University in admissions. Violations of the University instructions/rules may invite the position not to allow the students to appear at the University exams or the disaffiliation of the colleges.
